- (l) om krygstuig, met inbegrip van krygstuig wat vir uitvoer nodig is, te ontwikkel, te vervaardig, te versien, te herstel, in stand te hou, vir eie rekening of as verteenwoordiger van 'n ander persoon te koop, te verkoop, in te voer of uit te voer en die verkoop daarvan te bevorder deur reklame of andersins

Krygkor/Beleid mbt Krygstuigbemarkingspermitte

- Die datapakeienaar of die vervaardiger, of Stelseleienaar/stelselhuis (Multi-vervaardigde prod.), of Sub-stelseleienaars — individuele pogings ondersteun Instansies handelende in volmag van vervaardigers/datapakeienaars
- Produkte onder ontwikkeling — kwalifisering 'n vereiste; (onderhandelbaar)

ARTICLE 3 (2) (I) AND (IA) OF THE ACT ON ARMAMENTS DEVELOPMENT
AND - PRODUCTION

NO 57 OF 1968:

POWERS OF THE CORPORATION

- (I) to develop, manufacture, service, repair, maintain arms, including munitions that are necessary for export, for its own account or to buy, to sell, to import or to export as a representative of another person and to promote the sale by advertising or otherwise

- (IA) to exercise control over the development, manufacture, procurement, supply, export or marketing of munitions.

Why Weapons permits?

- Armscor and RSA want to maintain the image of a responsible supplier of Arms in an International community.
- Prevent weapons to fall in wrong hands
- Want to protect the RSA's strategic capabilities
- Want to protect sensitive procurement channels

Armcor/Policies regarding
Weapons marketing permits

- The data pack owner or the manufacturer, or
- System owner/system house (Multi-manufactured prod.), or
- Sub-system owners - individual efforts supported
- Institutions acting in authority from manufacturers/data pack owners
- Products under development - qualification is a requirement; (negotiable)
- Policy of healthy competition with regard to similar products
- Sensitive imported components, certain telecommunications and EW - is critical
- No royalties payable on hardware
- Technology Fee payable in respect of sales expertise after negotiating with Armcor and SADF
- Product -and supplier integrity remain important
- Take non-proliferation constraints into account
- Close cooperation with the National Governing Body regarding weapons of mass destruction
