
"Also convey to the Government of Turkey their utmost appreciation for having made available to UNCURK the most rewarding services of Ambassador Kestelli; and



THE CHRISTMAS DAY CONFLAGRATION IN SEOUL
AND THE MATTER OF THE R.O.K. DEFENCE POSTURE

Dear Mr. Narasimhan,

On 25 December 1971, a heartbreaking conflagration consumed the 22-story touristic Tae Yun Gak Hotel which was only completed in 1969. The number of those who lost their lives in the 10-hour blaze and the jumps to death heretofore total 164 and those hurt number 60. This is reported to be the worst hotel fire in history.

The point of this letter is to point out the pitiful laxity of fire-prevention and fire-construction and the pathetic provisions for fire-fighting in Seoul that have together contributed to the enormity of the losses incurred. These, along with the grossly over-populated and congested Capital justify, perhaps to a large degree, the rampant fear of a possible Blitzkrieg air attack on the City as well as the contemplated measures to enhance its defence posture. The population of the City, when I last left it at the end of 1964, was 2.5 million; now it stands at 6 million, a more-than-double increase in seven years.

Besides improving the hitherto neglected protection of Seoul, measures may be expected inter alia to limit the constant inflow of population from the rural to the urban areas, if not also to endeavour to depopulate the cities, especially the Capital.

These, along with the grossly over-populated and congested Capital justify, perhaps to a large degree, the rampant fear of a possible Blitzkrieg air attack on the City as well as the contemplated measures to enhance its defence posture. The population of the City, when I last left it at the end of 1964, was 2.5 million; now it stands at 6 million, a more-than-double increase in seven years.

Besides improving the hitherto neglected protection of Seoul, measures may be expected inter alia to limit the constant inflow of population from the rural to the urban areas, if not also to endeavour to depopulate the cities, especially the Capital.

The only other passage along similar lines occurred on 14 September 1969 when the National Assembly dealt with the Constitutional Amendment enabling the President to run for a third term. */

The adoption of the Special Law would be challenged for a long time by the opposition New Democratic Party as "railroading" or "steamrolling" and as an "illegal and void" act. Meanwhile it will be defended by the government Democratic Republican Party as the only legal means available to avert the "untenable", "unlawful" and "obstructionist" tactics by the Opposition.

The point basically in question is whether the act of passage would lead to "excessive" implementation, or worse, to the dissolution of the National Assembly, etc., which may adversely affect the image of the ROK on the international scene, especially at the UN level.

Only three reporters from two daily newspapers and a news agency were allowed to enter the conference room to cover the passage of the bill.

Chairman Koh Jae Pil of the Legislation-Judiciary Committee found no objection to passing the bill, without modification, as the DRP members had proposed. It took barely one minute in passing the bill at the Committee.

As soon as the Committee passed the bill, Speaker Paik Too Chin, opening the plenary session, said that he had to change the site for parliamentary discussion on the bill to the Foreign Affairs Committee conference room due to the occupation of the main chamber of the Assembly by the NDP members, and asked for the DRP members understanding. He also said that he had to summon the plenary session at 3 a.m. in accordance with Article 66 of the National Assembly Law 1/. Speaker Paik, omitting the normal procedures of giving explanations on the proposed bill, question and answer and general debate, passed the bill without modification. It took only two minutes from the opening to the closure of the session.

JAPAN'S POLICY TOWARDS THE ROK: FOREIGN MINISTER FUKUDA

Dear Mr. Narasimhan,

I am conveying to you the following on the reported significant remarks of Japanese Foreign Minister Takeo Fukuda in view of the leading role Japan has heretofore played in the consideration of the Korean question at the United Nations:

In a reply on 22 December to a questionnaire by the Donghwa News Agency in Seoul, Japanese Foreign Minister Takeo Fukuda said that, despite Japan's current approach toward the PRC and its move to expand exchanges with north Korea, there was no change whatsoever in its basic policy of maintaining cooperative relations with the ROK, as the only lawful Government on the Korean Peninsula.

There appeared, however, that Mr. Fukuda's statement contained implicit reservations which do not support the ROK stand unequivocally:

First, on the possible simultaneous invitation of south and north Korea to UN next year, Foreign Minister Fukuda said that the Japanese Government would act cautiously in consultation with friendly nations and in consideration of the situation on the Korean Peninsula at that time.

Second, commenting on the possible simultaneous admission into the United Nations of south and north Korea, Foreign Minister Fukuda said: "The Korean question involves a very complicated situation inherited from the past. The question of simultaneous admission of south and north Korea into the UN should be considered along with such situation and should be reviewed by taking into full consideration the position of the two parties and their wishes. It would be proper to cope with the matter after consultations with other Member States of the Organisation and in view of the contribution in easing tension in the Far East."

The remaining portion of the statement evidently is in full support of the ROK:

Regarding the Korean question at the United Nations, the Foreign Minister stated that the Japanese Government supported the presence in the ROK of the UN Command and the activities of UNCURK.


Minister Fukuda also stated that he could not think of peace and prosperity of Japan without peace and stabilisation on the Korean Peninsula. He said that the Japanese Government intended to render all possible assistance to the ROK in order to ensure further economic development and social well-being through the Third Five-Year Economic Development Plan of the ROK.

Commenting on the reports about the north Korean demand for the cancellation of the ROK-Japan Treaty, Minister Fukuda said: "We have never thought of scrapping the Treaty which serves as a basis for the friendly relations between the two countries".

Concerning Japan's contacts with north Korea, the Minister said: "We intend to dispose of such issues as the grant of Japanese loans to north Korea and entry into Japan by north Korean officials and reporters on a case-by-case basis".
