THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) : (a) The information is not readily available and is being collected from Indian Missions abroad ;

(b) Attached staff quarters have been constructed or purchased in 11 Indian Missions abroad. These quarters are not sufficient to provide accommodation to all the staff members ;

(c) The total expenditure on the renting of additional flats and bungalows for staff in 10 of these stations during 1971-72 was Rs. 36,33,915.38. Information relating to the residences in Pakistan is not readily available.

Information regarding the expenditure incurred in 1972-73 is not readily available and is being collected from Indian Missions abroad.
